BOARD APPROVAL OF THE REQUEST FROM COACH ZAVYER CRAFT & COACH COREY NESMITH FOR THE DISTRICT TO CONSIDER SUPPORTING THE MIDLAND 5^{TH} & 6^{TH} GRADE BOYS BANTAM BASKETBALL TEAM

1) Motion by Mr. D'Itri and seconded by Mr. McShane that the Board approve the request from Coach Zavyer Craft & Coach Corey Nesmith for the District to consider supporting the Midland 5th & 6th Grade Boys Bantam Basketball team with a monetary donation for this season. The total funds needed to operate the program is \$2,245 which covers the registration fee combined with the cost of referees for 12 total home games between 5th & 6th grade (6 per team). Any donation approved by the Board is greatly appreciated by the coaches and players. Pending verification of insurance.
